Enrollment Policy: Enrollment is a contract from 1st day of class through Recital. Nonrefundable annual enrollment fee due at time of enrollment. Cancellation of enrollment accepted with 30-day written notice & all fees due through end of 30-day notice. Enrollment accepted any time of dance year. Classes expected to be held in person at the ASD studio, 3320 Lake Lansing Rd, East Lansing. However, if we are unable to hold classes in person at the studio, alternate arrangements will be made. This could include, but not limited to, outdoors, an alternate location, or online using a service like Zoom. Your contract is for dance classes, not location of classes.

Injury or Loss: Ann's School of Dance or teachers are not responsible for injury or lost items.

Website: Refer to our website (www.annschoolofdance.com) for important notices and announcements.

Dress Code: The specific dress code is outlined on our website. Failure to follow the dress code may result in a student not being allowed to participate in class.

Attendance: No refunds for missed classes, but makeups possible with instructor approval/space availability.

Inclement Weather: Ann's School of Dance follows the East Lansing Schools' weather closings. There will be no classes held if East Lansing Schools are closed due to weather.

Full Season Calendar: Includes holiday breaks and is posted on our website and at the studio.

Observation Weeks: Classes can be viewed the first full week of November, January, and March.

Photo/Video: I understand and give permission for my child's photo and video to be used in Ann's School of Dance marketing, advertising, and promotional material now and in the future.

Recital & Costumes: All audience members will need to purchase tickets in March for the Recital, which is held at the end of the regular dance season (typically end of April or beginning of May). \$90 per recreational costume, \$95 per Team routine costume. 100% total costume fee due 1st Thursday of October. Costumes are not refundable & tights may only be exchanged for a different size during the current dance season.

ASD Tuition & Fees Policy ● September 2023 – May 2024

- ✓ **Credit/Debit Card on File with Ann's School of Dance Inc. (ASD)** - All accounts MUST have a credit/debit card (Mastercard or Visa only) on file with ASD in order to enroll in classes, no exceptions, even if tuition payment option is FULL YEAR.
- ✓ **Forms of Payment Accepted** - ASD accepts cash, check, Mastercard, and Visa. There is a \$30 fee for returned checks. If a check is returned NSF, future payments will only be accepted by cash, money order, or valid credit card.
- ✓ **Tuition Payment Options** - Tuition is based on the regular dance season program. Tuition is *not* based on how many classes are held per month. The child of anyone with an overdue balance may be ineligible to participate in class or perform in the annual recital.

Initial preferred tuition payment option:

_____ (initial here) **FULL YEAR.** One-time payment at beginning of regular dance season. Full year tuition will be reduced by 5% if paid using cash or check no later than September 11, 2023.

_____ (initial here) **AUTOMATIC DEDUCTION OF THREE EQUAL PAYMENTS***. Total tuition will be divided into 3 payments. These payments will be automatically charged to credit/debit card on file on the 1st Thursday in the months of September 2023, December 2023, and March 2024.

_____ (initial here) **AUTOMATIC DEDUCTION OF 7 EQUAL MONTHLY PAYMENTS***. Total tuition will be divided into 7 payments. Monthly payments will be automatically charged to credit/debit card on file on the 1st Thursday of each month starting in September 2023 through March 2024.

***IMPORTANT** If you wish to pay with cash, check, or an alternate credit/debit card, you may do so by delivering it BEFORE the 1st Thursday of the month. If the alternate payment method is not received by the 1st Thursday of the month, the credit/debit card on file will be charged.

- ✓ **Other Dance-Related Fees:** Unless alternate payment is arranged before the due date, the credit/debit card on file will be used to pay for dance-related fees including, but not limited to, annual enrollment and costume fees.
- ✓ **Delinquent Payments:** If any Tuition or dance-related fees are not paid by the stated due date, the credit/debit card on file will be charged for those fees. There is a \$35 late fee if the card is declined and alternate payment is not made immediately. A dancer may be ineligible to participate in class or perform in the annual recital due to unpaid balances.
